RE: Notice of Planned Action

To Whom It May Concern:

As you may know, GoHealth, LLC and Norvax, LLC (“the *Company*”) recently filed for Chapter 11 bankruptcy as part of a prepackaged restructuring plan. Due to economic difficulties, the Company, located at 222 West Merchandise Mart Plaza, Suite 1750, Chicago, Illinois 60654 (the “*Merchandise Mart*”), will be fully shutting down the majority of its current operations. Employees working at and/or reporting to the Merchandise Mart are expected to be separated from employment beginning on November 5, 2026, with all separations accomplished by December 31, 2026. One Hundred and Eleven (111) of the employees working at and/or reporting to the Merchandise Mart are employed on a full-time basis and 103 of these employees will be terminated. The employment losses are expected to be permanent and there will not be any bumping rights. None of the employees being terminated are represented by a union. The Company’s Federal Identification Numbers, or FEINs, are [REDACTED] and [REDACTED] respectively.

A list of the job titles of the affected positions, and the number of affected employees in each job classification, is attached hereto as **Appendix A**.

To the extent notice is required under the Worker Adjustment and Retraining Notification Act (“*WARN*”), 29 U.S.C. § 2101, *et seq.*, or any other laws, this letter shall constitute the best practicable notice under such laws given the above-referenced circumstances.
